1st RACE CLEAR
 2nd RACE Voided claim - used stable name only
 3rd RACE Race 3 was taken off the turf and contested on the main track. The change was posted and announced prior to the opening of wagering.

4th RACE #4 "Aflleet Diva" (David Flores) unseated her rider in the post parade, was quickly caught, remounted, and the race was without incident.

5th RACE #6 "Fighting Seabee" (Brian Hernandez, Jr.) was fractious in the gate, charged the front doors and popped them open, but was held in place by the assistant starter. The doors were closed and the start was without incident.

6th RACE Race 6 was taken off the turf and contested on the main track. The change was posted and announced prior to the opening of wagering.

#8 "Big Woo" (Tyler Gaffalione) broke slowly, trailed the field and was eased. The horse, who left the track on his own power, was evaluated by the KHRC veterinarians and was placed on the See State Vet list.

7th RACE CLEAR

8th RACE #7 "Lady Speightspeare" (Emma-Jayne Wilson) was injured in the starting gate and was a late scratch on the advice of the KHRC veterinarian.


9th RACE CLEAR


10th RACE #12 "Sara Sea" (David Cohen) charged the gate and popped the front doors open, but was held in place.


#2 "Music City Star" (Florent Geroux) broke through the gate prior to the start and unseated her rider. The horse was caught, examined by the KHRC veterinarian, remounted, and reloaded.

The eventual start was without incident.
