1st RACE Voided claim - track misspelled

2nd RACE The claim of #7 "Garmento" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3rd RACE There were two claims submitted for #2 "Grand Jury" and both were approved by the Horseman's Bookkeeper prior to the race. The post-race shake was won by owners Peter Proscia and David Staudacher. While the horse was in the test barn and prior to the transfer to the claimants, the Horseman's Bookkeeper notified the stewards that there had been an error made and that the connections that won the shake did not have sufficient available funds for the claim. The claim submitted by Proscia and Staudacher was then voided by the stewards and the horse was awarded to Phillip Ward, the owner that had submitted the other claim that was valid. The proper transfers were made by the Horseman's Bookkeeper and the horse was released to Phillip Ward.

4th RACE An objection was lodged by the rider of second place #5 "Unlimitedpotential" (John Velazquez) alleging interference by the rider of the unofficial winner #2 "Speed Bias" (Tyler Gaffalione) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that the slight contact that occurred was actually initiated by #5 drifting out slightly into #2. There was no change in the order of finish and the race was posted official.






7th RACE #10 "Change of Control" (Colby Hernandez) was a late scratch from the post parade on the advice of the KHRC veterinarian.
