RACE Both #7 "Siege of Boston" (Irad Ortiz, Jr.) and #9 "Genius Jimmy" (John Velazquez) broke through the gate prior to the start, but the riders stayed aboard. In addition, #8 "The Minkster:" (Seldon Russell) popped the front doors of the gate open, but was held in place by the assistant starter. #7 and #9 were both examined and approved by the KHRG veterinarian, were reloaded, and the start was without incident.

RACE CLEAR

10th RACE A Stewards Inquiry was posted involving fourth place #11 "Liam's Latte" (Victor Espinoza) and eighth place #9 "Unlikely Queen" (Gabriel Saez) near the 1/16 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #11 angled in towards the rail while not clear, causing #9 to clip heels and steady. For the interference, #11 was disqualified from fourth and placed eighth, behind #9. Official order of finish: 7-1-3-2-13
