TEST: 1<sup>st</sup> 3 & 6 (C 5-voided), 2<sup>nd</sup> 3 (C 5),  
3<sup>rd</sup> 2-voided & 7-voided (C 10, 11 & 12), 4<sup>th</sup> 2 & 4, 5<sup>th</sup> 8 & 9, 6<sup>th</sup> 4 & 5,  
7<sup>th</sup> 2 & 11, 8<sup>th</sup> 6 & 7, 9<sup>th</sup> 4, 5 & 7, 10<sup>th</sup> 3 & 10.

1<sup>st</sup> RACE #4 "Cold as Hell" (Jaime Torres) stumbled at the start and unseated his rider. The horse ran with the field and was caught without incident. Both horse and rider escaped injury.

The claim of #5 "Mac Daddy Too" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4<sup>th</sup> RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

Program correction: #4 "Adaay In Asia (GB)" was mistakenly listed to race with Lasix in the official program. The error was discovered in a timely manner and the horse was permitted to race without the medication. The correction was posted and announced prior to the opening of wagering.
