1st RACE #3 "Katie the Cutie" (Jack Gilligan) was a late scratch from the post parade on the advice of the KHRC veterinarian.

2nd RACE The race was taken off the turf and contested on the main track.

Super High Five wagering was not offered when the field was reduced to six prior to the opening of wagering.

3rd RACE An objection was lodged by the rider of second place #4 "Satchel de Ritches" (Tyler Gaffalione) alleging interference by the rider of the unofficial winner #5 "Loopallu" (Mitchell Murrill) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence to warrant a disqualification and the race was posted official.




