3rd RACE Voided 2 claims - submitted by the same stable for a single horse.
#3 "Charliecando" (James Graham) stumbled at the start and unseated his rider. The horse ran with the field and was caught without incident. The rider was not injured.

4th RACE The race was taken off the turf and contested on the main track. The change was posted and announced prior to the opening of wagering.

5th RACE CLEAR
6th RACE #1 "Be Like Water" (Robby Albarado) was injured in the starting gate and was a late scratch on the advice of the KHRC veterinarian.

An objection was lodged by the rider of second place #3 "Late Dolce" (Mitchell Murrill) alleging interference by the rider of the unofficial winner #9 "Color of Dawn" (Florent Geroux) near the 1/8 pole. After reviewing the race replay and interviewing the riders the stewards determined that there was no evidence of interference to warrant a disqualification and the race was posted official.

7th RACE There was a 35 minute weather delay while storms with lightning passed through the area. Horses remained in the paddock during the delay.

The race was taken off the turf and contested on the main track. The change was posted and announced prior to the opening of wagering.
