TEST: 1<sup>st</sup> 2 & 4 (C 1 & 3), 2<sup>nd</sup> 1 & 5, 3<sup>rd</sup> 1 & 2 (C 4, 5, 6 & 7-voided), 4<sup>th</sup> 5 & 7, 5<sup>th</sup> 4 & 8, 6<sup>th</sup> 7 & 9, 7<sup>th</sup> 2 & 4, 8<sup>th</sup> 4 & 9, 9<sup>th</sup> 5 & 6 (C 2, 3, 9 & 10).

1<sup>st</sup> RACE Voided claim - owner misspelled  
Voided claim - no date listed

2<sup>nd</sup> RACE An objection was lodged by the rider of second place #5 "Carmichael" (Rafael Bejarano) alleging interference by the rider of the unofficial winner #1 "Super Design" (Joel Rosario). After reviewing the race replay and interviewing the riders, the stewards determined that there was no interference and the race was posted official.

3<sup>rd</sup> RACE Voided claim - horse misspelled  
Voided claim - wrong race number on envelope

The claim of #7 "Trappe Valley" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4<sup>th</sup> RACE A Stewards Inquiry was posted and in addition, an objection was lodged by the rider of fourth place #6 "Bear Oak" (Florent Geroux) alleging interference by the rider of second place #4 "Time for Trouble" (Corey Lanerie). After reviewing the race replay and interviewing the riders, the stewards determined that #6 on the inside, came out and made contact with #4, causing #4 to turn and make additional contact with the #6 on the inside. As the interference was determined to be caused by the rider who lodged the objection, there was no change in the order of finish and the race was posted official.


5<sup>th</sup> RACE #11 "Bravo Kitten" was a late scratch while in the holding barn and prior to her arrival in the paddock when the KHRC veterinarian observed blood in her nostrils. It was determined that the horse had injured herself in the barn and she was placed on the See Vet list.


6<sup>th</sup> RACE #6 "Adalinda" (Isaiah Wiseman) flipped and unseated her rider in the starting gate. The rider was injured in the incident. The KHRC veterinarian approved the horse to start, but when no substitute rider was available the horse was a late scratch by the stewards.
