3rd RACE A Stewards Inquiry involving an incident in the stretch was posted. In addition, an objection was lodged by the rider of third place #4 "All Eyes West" (Mitchell Murrill) alleging interference by the rider of second place #1 "Blueridge Mountain" (Declan Carroll) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #1 came out leaving the 3/16 pole and bumped #4, causing him to steady sharply and lose momentum. For the interference #1 was disqualified from second and placed third behind #4.
Official order of finish: 3-4-1-5

4th RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

5th RACE Voided claim - no funds

6th RACE An objection was lodged by the rider of second place #2 "Coltonator" (Ricardo Santana, Jr.) alleging interference by the rider of the unofficial winner #4 "Shashashakemeup" (Corey Lanerie) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #4 kept a straight course and #2 lacked room when third place finisher #1 "High Proof" (Joseph Talamo) took a slight step out before being passed by #2. There was no change in the order of finish and the race was posted official.
