1st RACE #6 "Sprinklehead" (Reylu Gutierrez) unseated his rider in the post parade and ran loose, hitting the rail several times prior to being caught by the outrider. After being evaluated, the horse was a late scratch on the advice of the KHRC veterinarian.

#4 "My Miracle Man" (James Graham) was a late scratch from the post parade on the advice of the KHRC veterinarian.

2nd RACE Voided claim - insufficient funds

The winner, #8 "Urbanite" (Albin Jimenez) required the assistance of the KHRC veterinarians and the horse ambulance after pulling up. The horse, who had a blood sample drawn in the ambulance and was excused from the test barn, appeared to have suffered an injury to his right foreleg and was released to the care of the private veterinarian.
