A Stewards Inquiry was posted involving the start of #6 "December Seven" (Joseph Talamo). After reviewing the replay of the start and interviewing the starter and rider, the stewards determined that the horse reared up at the break after having been released by the assistant starter and had been afforded a fair start. There was no action taken and the race was posted official.

4<sup>th</sup> RACE CLEAR  
5<sup>th</sup> RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

6<sup>th</sup> RACE The claim of #2 "Poirier" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

7<sup>th</sup> RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

8<sup>th</sup> RACE CLEAR  
9<sup>th</sup> RACE A Stewards Inquiry was posted involving the stretch and, in addition, there was an objection lodged by the rider of fifth place #3 "Royal Mesa" (Rafael Bejarano) alleging interference by the rider of second place #2 "Multiplier" (Tyler Gaffalone) in the stretch. There was also objections lodged by both the rider of third place #8 "Lord Dragon" (David Cohen) and #2 alleging interference by the rider of the unofficial winner nearing the finish. After reviewing the race replay and interviewing the riders the stewards determined that the #3 was being passed on both sides when steadied, and the objections made by #2 and #8 were disallowed as #5 came out to them in the stretch and took a final step out just before the wire. There was no change in the order of finish and the race was posted official.
