RACE #1 "Mo Hair Sam" (Cristian A. Torres) was a late scratch from the post parade on the advice of the KHRGC veterinarian.

9th RACE #1 "Ferocious" (Luis Saez) was fractious in the starting gate and unseated his rider. The horse was backed out and examined and approved by the KHRGC veterinarian, remounted, reloaded, and the start was without incident

An objection was lodged by the rider of second place #1 "Ferocious" (Luis Saez) alleging interference by the rider of the unofficial winner #5 "East Avenue" (Tyler Gaffallione) in the first turn. After reviewing the race replay and interviewing the riders, the stewards determined that #5 angled in slightly as #1 bore out slightly from the rail to cause the tight quarters. #3 "Optical" (James Graham) checked when he lacked room between #1 and #5, then trailed the field and was eased. There was no change in the order of finish and the race was posted official
