TEST: 1st 2 & 7 (C 1, 3, 5, 6, 8 & 10), 2nd 5 & 6, 3rd 7 & 8, 4th 8 & 9, 5th 11 & 12, 6th 8 & 9, 7th 3, 5, 7 & 8, 8th 2, 3, 7 & 11, 9th 1, 2, 4 & 5, 10th 1 & 2.

5th RACE A Stewards Inquiry was posted involving the top 2 finishers and, in addition an objection was lodged by the rider of second place #11 "Jag Warrior" (Martin Garcia) alleging interference by the unofficial winner #12 "Olga Isabel" (Joel Rosario) near the ¼ pole. After reviewing the race replay and interviewing the riders, the stewards determined that #12 drifted out approaching the ¼ pole, carrying #11 out and causing him to lose ground. For the interference, #12 was disqualified from first and placed second, behind #11.
Official order of finish: 11-12-3-4

6th RACE #2 "My Uncle Leon" (Flavien Prat) finished fifth and required the assistance of the KHRC veterinarians and the hors ambulance. It was determined that the horse had returned lame and he was placed on the See State Vet list.

9th RACE A Stewards Inquiry was posted involving second place #2 "Chop Chop" (Joel Rosario), third place #4 "Raging Sea" (Jose Ortiz) and fourth place #5 "Xigera" (Joseph Talamo) and, in addition objections were lodged by both the rider and trainer of #5 alleging interference by the rider of #4 near the 1/16 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #4 bore out and made contact with #5, causing her to check sharply to avoid clipping the heels of #2 to her outside. The stewards also determined that #2 maintained a straight course. For the interference, #4 was disqualified from third and placed fourth, behind #5.
Official order of finish: 1-2-5-4

10th RACE An incident occurred near the 3/8 pole involving ninth place #10 "Longpants Required" (Irad Ortiz, Jr.). #10 angled in and caused several horses to steady and alter course. None of the affected horses finished on the board and therefore no Inquiry was posted. The matter was reviewed by the stewards. Due to the order of finish there was no change made and the race was posted official.
