1st RACE Voided claim - owner misspelled

2nd RACE #7 "He's a Angel" (Javier Padron-Barcenas) was fractious, injured himself behind the starting and was a late scratch on the advice of the KHRC veterinarian.

3rd RACE CLEAR

4th RACE Voided claim - wrong race number on envelope
Voided claim - no owner listed

An objection was lodged by the trainer (Robertino Diodoro) and rider of #2 "Town Classic" (David Cohen) alleging interference by the rider of the unofficial winner #7 "Spycraft" (Adam Beschizza) near the 4 1/2 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #2 lacked room between horses when his horse clipped the heel of #7. There was no change in the order of finish and the race was posted official.

The claims of both #5 "My Man Flintstone" and #7 "Spycraft" were voided pursuant to 810 KAR 4:050 when the horses were placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.

5th RACE Voided claim - funds in wrong account

#4 "Brad's Time" (David Cohen) unseated his rider in the post parade and ran loose. He evaded the outriders for some time before being a late scratch by the stewards. Both horse and rider escaped injury.






