TEST: 1st 4 & 6 (C 3), 2nd 2 & 5 (C 4), 3rd 1 & 4, 4th 3 & 12 (C 1, 4 & 11), 5th 1 & 3 (C 8), 6th 1 & 3, 7th 3 & 4 (C 6), 8th 2 & 9 (C 6), 9th 2, 5, 8 & 10, 10th 7 & 8.

1st RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

4th RACE #4 "Nice Work" (Julien Leparoux) stumbled at the start and unseated his rider. The horse ran with the field until he was caught by the outrider past the finish. Both horse and rider escaped injury.

A Stewards Inquiry was posted involving an incident approaching the 5/8 pole and involving fifth place #11 "Park Ridge Benny" (Ricardo Santana, Jr.) and eleventh place #7 "College Party" (Declan Cannon). After reviewing the race replay and interviewing the riders, the stewards determined that #11 came over in front of the #7 while not clear, causing #7 to clip his heel and steady sharply. For the interference, #11 is disqualified from fifth and placed 11th behind #7. Official order of finish: 3-12-13-2-10

5th RACE An objection was lodged by the rider of second place #1 "Tesorina" (Gerardo Corrales) alleging interference by the rider of the unofficial winner #3 "Flatoya" (Chris Landeros) inside the 1/16 pole. After reviewing the race replay and interviewing the riders, the stewards determined that the rider of #1 checked and took his horse to the inside as the #3 was drifting out to her. There was no change in the order of finish and the race was posted official.






