
7th RACE Apprentice jockey Brooke Bays rode #4 "Beau Day", her third probationary mount, and was granted an Apprentice Jockey license.

An objection was lodged by the rider of second place #7 "Fashion King" (Tyler Gaffalione) alleging interference by the rider of the unofficial winner #8 "Raise Cain" (Gerardo Corrales) near the 3/16 pole. After reviewing the race replay and interviewing the riders, there was insufficient evidence to warrant a disqualification and the race was posted official.
