1st RACE Triecta and Show wagering were not offered when the field was reduced to four prior to the opening of wagering.

2nd RACE Voided claim - used stable name only

The claim of #8 "Gesture" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

9th RACE An objection was lodged by the rider of second place #2 "Cash Out" (Rafael Bejarano) alleging interference by the rider of the unofficial winner #9 "Singita Dreams" (Gabriel Saez) near the 1/4 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #9 ducked out suddenly in front of #2 near the 1/4 pole, causing the #2 to steady and change course to the outside. For the interference #9 was disqualified and placed second, behind #2. Official order of finish: 2-9-8-4

10th RACE A Stewards Inquiry was posted involving the top two finishers in the stretch and, in addition an objection was lodged by the rider of second place finisher #6 "Smart Call" (Ricardo Santana, Jr.) alleging interference by the rider of the unofficial winner #10 "Monte Ne" (Corey Lanerie). After reviewing the race replay and interviewing the riders, the stewards determined that #10 drifted out repeatedly through the stretch and impeded the progress of #6. For the interference, #10 was disqualified and placed second, behind #6. Official order of finish: 6-10-7-8-1

The claim of #1 "Canoe" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
