#5 "Mo's Mojo" (Francisco Arrieta) was a late scratch from the post parade on the advice of the KHRC veterinarian. The late scratch reduced the field to four, necessitating the cancellation of the Trifecta. The mutuels department made the proper refunds.

4th RACE CLEAR

5th RACE #4 "Classic Claire" (Florent Geroux) unseated her rider in the post parade but did not get loose. The filly was remounted and the race was without incident.

6th RACE #1 "Mo Hope" (Corey Lanerie) was a late scratch from the post parade on the advice of the KHRC veterinarian.

7th RACE Voided claim - track misspelled

#11 "Argumental" (Ricardo Santana, Jr.) was pulled up near the 1/2 mile pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was later reported that the horse was lame and she was placed on the See State Vet list.

8th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

9th RACE CLEAR

10th RACE The claim of #1 "Honest Opinion" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
