1st RACE Dead Heat for SHOW

2nd RACE #2 "Trust issues" (Jamie Torres) unseated his rider in the post parade and ran loose until he was apprehended by the outriders. The KHRC veterinarian approved the horse, who was then remounted. The race was without incident.

3rd RACE The claim of #2 "Heartbreaker" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4th RACE #7 "Port Townsend" (Cristian Torres) unseated his rider behind the starting gate, but the rider heroically held onto the horse. The horse was remounted, loaded, and the start was without incident.


