
A Stewards Inquiry was posted involving an incident near the 5/8 pole. After reviewing the race replay and interviewing the riders of third place #7 "Dewy's Beast" (Adam Beschizza), fourth place #1 "Sound Doctrine" (Luis Saez) and sixth place (last) #5 "Flotation Station" (Keith Asmussen), the stewards determined that #7 angled in while not clear, and caused both #1 and #5 to check sharply. For the interference #7 was disqualified and placed sixth (last) behind #5. Official order of finish: 3-9-1-2

8th RACE #5 "Dream On Stormy" (Gavin Ashton) was a late scratch from the post parade on the advice of the KHRGC veterinarian.

9th RACE CLEAR

10th RACE #1 "Star Topper" (Corey Lanerie) was a late scratch from the post parade on the advice of the KHRGC veterinarian.

A Stewards Inquiry was posted involving the stretch and, in addition, an objection was lodged by the rider of second place #7 "Parkway" (Samuel Camacho, Jr.) alleging interference by the rider of the unofficial winner, #8 "Overstatement" (Evin A. Roman) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #8 drifted in slightly while clear as #7 changed course to the outside. There was no interference and the race was posted official.
