3<sup>rd</sup> RACE Voided claim - used stable name only

4<sup>th</sup> RACE CLEAR

5<sup>th</sup> RACE #7 "She's Takin Charge" (Brian J. Hernandez, Jr.) was a late scratch from the post parade on the advice of the KHRG veterinarian.

6<sup>th</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

#8 "Villian" (Jose L. Ortiz) finished fifth and required the assistance of the KHRG veterinarians and the horse ambulance. It was later reported that the horse had returned lame and he was placed on the See State Vet list.
