1st RACE The claim of #6 "Sonic City" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

2nd RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

#3 "Kadri" (John McKee) was a late scratch from the post parade on the advice of the KHRC veterinarian. The late scratch reduced the field to four, necessitating the cancellation of the Trifecta. The mutuels department made the proper refunds.
