1st RACE #9 "Flaming Embers" (Joseph C. Bealmear) trailed the field, was pulled up at the 1/4 pole, and required the assistance of the KHRG veterinarians and the horse ambulance. The horse was placed on the See State Vet list.

2nd RACE #2 "Costa Amalfitana" (Joseph Trejos) was injured in the starting gate and was a late scratch on the advice of the KHRG veterinarian. The scratch reduced the field to five, necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds.

4th RACE There was a 30 minute delay due to a mechanical issue with the starting gate. During the delay, the horse were returned to the paddock, jockeys dismounted and overgirths removed. Ultimately, the back up starting gate was put in place and the start and race were without incident.
