4<sup>th</sup> RACE A Stewards Inquiry was posted involving the stretch and, in addition, an objection was lodged by the rider of third place #5 "Stylish Sue" (Tyler Gaffalione) alleging interference by the rider of the unofficial winner, #2 "She's Lookin Lucky" (Axel Concepcion) from the 1/8 pole to the finish. After reviewing the race replay and interviewing the riders, the stewards determined that #2 drifted out through the stretch, carrying #5 out and impeding her progress. For the interference, #2 was disqualified and placed third, behind #5. Official order of finish: 6-5-2-3-7
