TEST: 1<sup>st</sup> 1 & 6 (C 3), 2<sup>nd</sup> 2 & 4, 3<sup>rd</sup> 9 & 11, 4<sup>th</sup> 1 & 5, 5<sup>th</sup> 5 & 8, 6<sup>th</sup> 2 & 8, 7<sup>th</sup> 6 & 14, 8<sup>th</sup> 8 & 12, 9<sup>th</sup> 5 & 7, 10<sup>th</sup> 9 & 11, 11<sup>th</sup> 9 & 11.

1<sup>st</sup> RACE #2 "Proven Hope" (Cristian Torres) was injured in the post parade and was a late scratch on the advice of the KHRGC veterinarian. The scratch reduced the field to five, necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds. A claim that had been submitted for the horse was voided.

2<sup>nd</sup> RACE CLEAR

3<sup>rd</sup> RACE A Stewards Inquiry was posted shortly after the start when #7 "Shadow Coast" (Tyler Gaffalione) unseated his rider. After reviewing the race replay and interviewing the riders of second place #9 "Camp Hale" (Brian Hernandez, Jr.) and ninth place #5 "T Kraft" (Jaime A. Torres), the stewards determined that #7 clipped heels and unseated his rider when he lacked room between horses. There was no change in the order of finish and the race was posted official. Gaffalione was transported to the hospital for evaluation. The horse escaped injury.

8<sup>th</sup> RACE An objection was lodged by the rider of eighth place #10 "Hilarious Affair" (Jose Ortiz) alleging interference by both the riders of sixth place #5 "Final Verdict" (Vincent Cheminaud) and fourth place #7 "Mid Day Image" (Samuel Camacho, Jr.) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #10 checked when he lacked room to go between horses. There was no change in the order of finish and the race was posted official.

9<sup>th</sup> RACE CLEAR

10<sup>th</sup> RACE A Stewards Inquiry was posted and, in addition, an objection was lodged by the rider of fourth place #10 "Welaka" (Adam Beschizza) alleging interference by the rider of the unofficial winner #11 "Surface to Air" (Fernando Jara) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #11 ducked in near the 1/8 pole and caused #10 to steady and lose momentum. For the interference #11 was disqualified and placed fourth, behind #10. Official order of finish: 9-4-10-11
