TEST: 1st 1 & 2, 2nd 4 & 7 (C 6), 3rd 2 & 3, 4th 1 & 4, 5th 4 & 6, 6th 5 & 6 (C 3), 7th 1 & 9, 8th 10 & 11, 9th 1 & 10 (C 7 - voided and 9 - voided).

1st RACE CLEAR
2nd RACE CLEAR
3rd RACE CLEAR
4th RACE #11 "Combating" arrived past the Lasix administration deadline and was permitted to race without the medication. The change was posted and announced prior to the opening of wagering.

5th RACE An objection was lodged by the rider of #7 "Sunshine City" (Gerardo Corrales) alleging interference by both the rider of second place #6 "Yellowstone Girl" (Florent Geroux) and the unofficial winner #4 "Chandelle" (Tyler Gaffalione) in the stretch. After reviewing the race replay and interviewing the riders the stewards determined that the #7 was being passed on both sides when steaddled. There was no change in the order of finish and the race was posted official.

#4 "Chandelle" was lame in the test barn after the race. A blood sample was drawn and the horse was excused.

6th RACE CLEAR
7th RACE #10 "Conformist" (Tyler Gaffalione) was a late scratch from the post parade on the advice of the KHRC veterinarian.

An objection was lodged by the rider of fifth place #4 "Two Worlds" (David Cohen) alleging interference by the rider of second place #3 "Sam and Sy" (Florent Geroux) near the 1/16 pole. After reviewing the race replay and interviewing the riders there was no change in the order of finish and the race was posted official.

8th RACE Superfecta, Trifecta and Show wagering were not offered when the field was reduced to four prior to the opening of wagering.

9th RACE The claims of both #7 "Continuum" and #9 "Albert's Barn" were voided pursuant to 8:10 KAR 4:050 when the horses were placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.
