1st RACE The claims of both #4 "Mr Big Stuff" and #6 "Who's Snow Trouble" were voided pursuant to HISA Rule #2262 when the horses were placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.

2nd RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

#1 "Jump Into the Fire" (Luan Machado) was a late scratch from the post parade on the advice of the KHRC veterinarian. The scratch reduced the field to four, necessitating the cancellation of the Trifecta. The mutuels department made the proper refunds. Two claims that had been submitted for #1 were voided.
