5th RACE Voided claim - insufficient funds

A Stewards Inquiry was posted involving #7 "Mint" (Tyler Gaffalione) at the start. After reviewing the race replay and interviewing the starter, the stewards determined that the horse caused his own trouble when he reared at the start, hitting the top of the gate and dislodging a pad. Because the front door opened properly and the horse was not restrained by the assistant starter, #7 was considered a starter and there was no action taken.

8th RACE #8 "Western River" (Ricardo Santana, Jr.) was pulled up near the 3/16 pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was later reported that the horse had suffered an injury to his right knee and was transported by his connections to a Lexington clinic.
