- 5th RACE #10 "M B's Munning" (Gabriel Saez) was a late scratch from the post parade on the advice of the KHRG veterinarian.

After the transfer of the claimed horse #11 "Dutch Mills" to owner Shane Meyers the stewards were notified by the Horseman's Bookkeeper that Meyers did not have the required funds in his account. The stewards voided the claim and ordered the return of the horse to the previous owner, Steven M. Asmussen.
