An objection was lodged by the rider of fourth RACE place #2 "Don'tmindifido" (Luan Machado) alleging interference by the rider of third place #5 "Little Value Added" (Mario Gutierrez) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #2 lacked room to go between horses and that there had been no interference. There was no change in the order of finish and the race was posted official.

RACE Voided claim - no funds

A Stewards Inquiry was posted involving the start of eighth place (last) #7 "Seek and Find" (Irving Moncada) who broke well behind the field. After reviewing the race replay and interviewing Moncada, the stewards determined that the filly had not been precluded from obtaining a fair start, but had reared and hit the gate at the break, causing her own trouble. There was no action taken.

Super Hi-5 wagering was not offered when the RACE field was reduced to six prior to the opening of wagering.
