1st RACE The claim of #9 "Fashion King" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

2nd RACE Summer Pauly rode #4 "Lady Livermore", her first probationary mount.

The claim of #8 "Gatita Suave" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3rd RACE CLEAR

4th RACE #7 "Tepper" (Gabriel Lagunes) was a late scratch from the post parade on the advice of the KHRC veterinarian.

Summer Pauly rode #9 "Amazing Justice", her second probationary mount.

The claim of #1 "Punctuality" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.


5th RACE CLEAR


6th RACE Summer Pauly rode #1 "Mali Bali", her third probationary mount, and was granted an Apprentice Jockey license.

7th RACE The claim of #12 "Joker On Jack" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

8th RACE #5 "Forgotten Peace" (Joseph Ramos) finished ninth and required the assistance of the KHRC veterinarians and the horse ambulance. It was reported that the horse had BLED and she was placed on the See State Vet list.

9th RACE There was a 20 minute delay when #5 "Tazawako (JPN)" (Martin Garcia) backed up abruptly while attempting to load in the gate, reared up, fell to the side and hit her head against inner rail. The horse became lodged under the inner rail and began to convulse. Due to the seriousness of her condition, the filly was humanely euthanized on the racetrack.
