5th RACE #6 "Misinformation" (Flavien Prat) finished fourth and stumbled and fell after the finish near the 7/8 pole, unseating his rider. The horse required the assistance of the KHRG veterinarians and the horse ambulance. It was later reported that the horse had returned lame and he was placed on the See State Vet list.

After reviewing the race replay, the stewards determined that the colt broke awkwardly, causing the rider to be unseated, and that no other horse was involved. The horse ran with the field and was caught without incident. The rider was not injured. There was no action taken and the race was posted official.
