#4 "Ceeky" (Tyler Gaffalione) was pulled up abruptly leaving the 3/8 pole and required the assistance of the KHRC veterinarian and the horse ambulance. It was determined that the horse had suffered a catastrophic injury to his right foreleg and he was humanely euthanized.

The claim of #1 "Tumbling Sky" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
