1st RACE #10 "Anytimeallthetime" (German Terraza) suffered a catastrophic injury to his left foreleg and fell leaving the 1/4 pole, unseating his rider. The KHRC veterinarians went to the fallen horse, who appeared to be unresponsive on the racetrack. It was reported that the horse was agonal and it was thought to be caused by the manner in which he fell. The horse was humanely euthanized by the KHRC veterinarian.

The human ambulance crew failed to respond to the fallen rider, who walked back to the jockey's quarters from the incident, only to later learn that he had suffered a fractured collarbone in the spill. Afterwards, the stewards met with the human ambulance crew supervisor to ensure that the lack of response would not be repeated in the future.

7th RACE #2 "Sirjus Dream" (Julio Felix) broke through the gate prior to the start, but the rider stayed aboard. Also, both #1 "Lightning Fire" (Joseph Ramos) and #3 "Quaria Comet" (Joseph Talamo) hit the front doors and popped them open. #3 was injured in the incident and was a late scratch on the advice of the KHRC veterinarian. The other two horses were examined and approved by the KHRC veterinarian and raced without incident.
