2nd RACE #3 "Messier" (John Velazquez) BLED and finished last. The horse, who required the assistance of the KHRC veterinarians and the horse ambulance, was placed on the See State Vet list.

5th RACE An objection was lodged by the rider of third place #1 "Slow Down Andy" (Mario Gutierrez) alleging interference by the rider of second place #9 "Cyberknife" (Florence Geroux) in the first turn. In addition, there was a Stewards Inquiry posted involving second place #9 and fourth place #5 "Gunite" (Tyler Gaffalione) in the stretch. After reviewing the race replay and interviewing the riders the stewards disallowed the rider objection because the rider of #1 alleged interference by the wrong horse, and that the slight interference to him was caused by a rival that finished behind him. The incident in the stretch was reviewed and the stewards determined that the brush that occurred when #9 angled in slightly toward #5 as he was running past him was not sufficient cause to warrant a disqualification and no action was taken. There was no change in the order of finish and the race was posted official.



8th RACE #14 "Domestic Spending (GB)" (Flavian Prat) was pulled up near the 7/16 pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was later reported that the horse was suspected to have suffered a pelvis injury and he was transported to a Lexington clinic for evaluation.

11th RACE #6 "Epicenter" (Joel Rosario) was pulled up leaving the 5/8 pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was later reported that the horse had suffered an injury to his right foreleg and he was transported to a Lexington clinic for evaluation.

12th RACE Super High Five wagering was not offered when the field was reduced to six prior to the opening of wagering.
