 7th RACE #8 "No Que No" (Francisco Arrieta) was a late scratch from the post parade on the advice of the KHRC veterinarian.

8th RACE CLEAR

9th RACE A Stewards Inquiry was posted due to an incident involving fourth place #8 "Dynadriver" (Corey Lanerie) and eighth place #5 "Tashan" (Martin Garcia) nearing the 3/16 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #8 came in and caused #5 to check sharply and lose all opportunity for a placing. For the interference, #8 was disqualified from fourth and placed eighth, behind #5.
 Official order of finish: 9-6-2-1

10th RACE A Stewards Inquiry was posted when #3 "Vertical Threat" (Adam Beschizza) fell and unseated his rider near the 5/16 pole. #5 "Rough Entry" (Brian Hernandez, Jr.) was unable to avoid the horse and fell over him, unseating his rider. After reviewing the race replay and interviewing the riders, the stewards determined that #3 ran up into the heels of third place #7 "Sir Alfred James" (John McKee) and caused the fall. There was no action taken and the race was posted official.
 #5 appeared to escape injury. #3 was transported to a clinic for evaluation. Neither rider was injured.
