After reviewing the race replay and interviewing the riders, the stewards determined that #3 broke slightly behind the field and that fourth place #4 "Mascara" (Gerardo Corrales) broke in slightly. #2 maintained a straight course from the start and did not interfere with #3. There was no change in the order of finish and the race was posted official
