4<sup>th</sup> RACE #2 "Splattered" (Gerardo Corrales) was pulled up near the 3/16 pole and required the assistance of the KHRGC veterinarians and the horse ambulance. After being transported to a clinic for evaluation, the filly was humanely euthanized due to a catastrophic injury to her left foreleg.


5<sup>th</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

6<sup>th</sup> RACE CLEAR

7<sup>th</sup> RACE An objection was lodged by the rider of third place #3 "La Marinera" (Rogelio Miranda) alleging interference by the rider of the unofficial winner #2 "Rosato" (Irving Moncada) shortly after the start. After reviewing the race replay and interviewing the riders, the stewards determined that #3 broke slightly behind the field and that fourth place #4 "Mascara" (Gerardo Corrales) broke in slightly. #2 maintained a straight course from the start and did not interfere with #3. There was no change in the order of finish and the race was posted official
