1st RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

2nd RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

#2 "Soco and Lime" (Emmanuel Esquivel) finished third, BLED, and required the assistance of the KHRG veterinarians and the horse ambulance. The horse was placed on the See State Vet list.

The claim of #3 "Vasa" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3rd RACE A Stewards Inquiry was posted when #7 "Mighty Nora" (Keith Asmussen) unseated her rider near the 7/16 pole. After reviewing the race replay and interviewing the riders of fifth place #1 "Mo Biscuit" (Walter A. Rodriguez), sixth place #3 "Don't mind if I do" (Jose L. Ortiz) and third place #3 "R Kendi" (Alexander Bendezu), the stewards determined that #3 angled out slightly and caused #7 to clip her heel, bobble and unseat her rider. For the interference, #3 was disqualified and placed sixth (last). There was no change in the order of finish and the race was posted official. The filly ran with the field and was caught without incident. Asmussen was transported to the hospital.

4th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

#3 "Deer District" (Luis Saez) broke through the gate prior to the start and unseated his rider, but the assistance starter held on to him. The horse was examined and approved by the KHRG veterinarian, rider remounted, and the start was without incident.

7th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

#10 "English Chunnel" (Jareth Loveberry) was eased and required the assistance of the KHRG veterinarians and the horse ambulance. It was later determined that the horse BLED and he was placed on the See State Vet list.
