5th RACE #5 "Apple Ever After" (Ricardo Santana, Jr.) was a late scratch from the post parade on the advice of the KHRC veterinarian.

6th RACE #1 "Maotai" (Rafael Mojica, Jr.) clipped heels with a rival while in tight quarters the 5/16 pole, stumbled and unseated her rider. #10 "Baby No Worries" (Emmanuel Esquivel) could not avoid colliding with #1 and unseating her rider when she did so. Neither horse fell and both ran behind the field and were caught without incident. Both riders were attended to by the human ambulance crews, who quickly responded to them, and both riders were transported to the hospital. It was later reported that neither rider had suffered a serious injury.

7th RACE There was a 15 minute delay to the start of race 7 while awaiting the return of the human ambulances as both had left the property to transport the riders that had been unseated in race 6. During the delay the horses remained in the paddock without incident.
