1st RACE A Stewards Inquiry was posted involving the stretch and, in addition, objections were lodged by the riders of both fifth place #8 "Jackys Back" (Joseph Ramos) and sixth place #5 "Pursuant" (Brooke Bays) alleging interference by the rider of third place #13 "Rhodesia" (Declan Cannon). After reviewing the race replay and interviewing the riders, the stewards determined that #13 bore in in the stretch, causing both #8 and #5 to check sharply and lose momentum. For the interference #13 was disqualified from third and placed sixth, behind #5.

#6 "Hazel Rah" (Jane Elliott) broke through the gate prior to the start, but the rider stayed aboard and the assistant starter gamely held on to the horse. The horse was examined and approved by the KHRC veterinarian, and the start was without incident.
