A Stewards Inquiry was posted involving the RACE stretch and, in addition, objections were lodged by the riders of both fifth place #8 "Jackys Back" (Joseph Ramos) and sixth place #5 "Pursuant" (Brooke Bays) alleging interference by the rider of third place #13 "Rhodesia" (Declan Cannon). After reviewing the race replay and interviewing the riders, the stewards determined that #13 bore in in the stretch, causing both #8 and #5 to check sharply and lose momentum. For the interference #13 was disqualified from third and placed sixth, behind Official order of finish: 10-4-2-8 #5.
