TEST: 1<sup>st</sup> 5 & 9, 2<sup>nd</sup> 1 & 7, 3<sup>rd</sup> 3 & 8 (C 6), 4<sup>th</sup> 4 & 8, 5<sup>th</sup> 8 & 11, 6<sup>th</sup> 4 & 7, 7<sup>th</sup> 2 & 10, 8<sup>th</sup> 3 & 5.

1<sup>st</sup> RACE An objection was lodged by the trainer (Karyn Wittek) of fifth place #8 "Bodieful (Declan Cannon) alleging interference by the rider of third place #11 "Slender Betsy" (Joseph Ramos) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.

2<sup>nd</sup> RACE #2 "Pasion Azteca" (Rogelio Miranda) unseated his rider in the post parade but did not get loose. The horse was remounted and raced without incident.

3<sup>rd</sup> RACE Voided claim - track misspelled on envelope

An objection was lodged by the trainer (Roddina Barrett) of seventh place #1 "Miss Super Saint" (Jane Elliott) alleging interference by the rider of fourth place #6 "A Real Hero" (Gerardo Corrales) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #6 angled in caused #1 to check sharply and cause #3 "Hashtag Winner" (Joseph Ramos), the eventual winner, to steady. For the interference #6 was disqualified from fourth and placed seventh, behind #1.
