Joseph C. Bealmear rode #9 "Old Fashioned Girl", his second probationary mount.

3<sup>rd</sup> RACE #2 "Way Too Smarte" (Alexander Bendazu) was eased and required the assistance of the KHRC veterinarians and the horse ambulance. It was determined that the mare had suffered a catastrophic injury to her left hind leg and she was humanely euthanized.

The claim of #11 "Red Pixie" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

#10 "Military Drill" (Gaddiel Martinez) was a late scratch from the post parade on the advice of the KHRC veterinarian. Six claims that had been submitted for the horse were voided.

The claim of #7 "Takafumi (BRZ)" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

5<sup>th</sup> RACE #7 "Western Moon" (Adam Beschizza) was a late scratch from the post parade on the advice of the KHRC veterinarian.

6th RACE CLEAR

7<sup>th</sup> RACE Joseph C. Bealmear rode #4 "Katie Got Lucky", his third probationary mount, and was granted an Apprentice Jockey license.

The claim of #5 "Three Coins" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

8<sup>th</sup> RACE An objection was lodged by the rider of fourth place #12 "Pine Knoll" (Tyler Conner) alleging interference by the rider of the unofficial winner #10 "Condemn" (Gerardo Corrales). After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence of interference to warrant a disqualification.
