4th RACE An equipment malfunction (broken inside rein) on #13 "Heaven and Earth" (Adam Beschizza) occurred several strides out of the starting gate. The rider was unable to control the horse, who ran extremely wide with the field and was pulled up by the outrider past the finish and without incident.

6th RACE #13 "Ellie Deli" arrived in the paddock with hind horseshoes that were not HISA compliant. The trainer opted to scratch the horse rather than race without the non-permitted hind horseshoes.

8th RACE CLEAR


9th RACE The trainer (Michael Slager) of eighth place #2 "Mining Camp" (Cory Orm) lodged an objection alleging interference by the rider of the unofficial winner #8 "Rate Confirmation" (Abel Lezcano) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence of interference to warrant a disqualification and the race was posted official.
