TEST: 1<sup>st</sup> 5 & 7, 2<sup>nd</sup> 9 & 11, 3<sup>rd</sup> 5-clm voided & 9, 4<sup>th</sup> 3 & 10 (C 2), 5<sup>th</sup> 2 & 5, 6<sup>th</sup> 3 & 7 (C 1), 7<sup>th</sup> 2 & 12, 8<sup>th</sup> 3-declared non starter-excused & 4.

DAY:14

1<sup>st</sup> RACE #4 "Point of Infinity" was a late scratch from the post parade on the advice of the KHRC veterinarian.

2<sup>nd</sup> RACE CLEAR

3<sup>rd</sup> RACE The claim of #5 "Chimaev" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3<sup>rd</sup> RACE CLEAR  
 4<sup>th</sup> RACE #4 "Elvis Just Elvis" (Samuel Bermudez) BLED and was pulled up near the 1/4 pole. The horse required the assistance of the KHRC veterinarians and the horse ambulance, and was placed on the See State Vet list.

8<sup>th</sup> RACE A Stewards Inquiry was posted shortly after the start when the starter contacted the stewards to inform them that two starting gate doors failed to open promptly. After reviewing the race replay and interviewing the starter, the stewards determined that the front doors of both eighth place #3 "Southern Sense"(Joseph Ramos) and the unofficial winner #4 "Strike Price" (Dylan Davis) opened after the rest of the field had been dispatched. The starter explained that a rapid and drastic drop in temperature during the post parade, when the light rain became a driving snowstorm, caused both doors to freeze shut. At the break, both horses charged the doors, breaking behind the field. As #4 overcame his adversity to finish first, there was no action taken. #3 was DECLARED A NON-STARTER and all wagers were ordered refunded by the stewards. The mutuels department made the proper refunds. A claim that had been submitted for #3 was voided.
