2<sup>nd</sup> RACE The claim of #4 "Believing" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

#9 "Translate" arrived in the paddock with front and hind horseshoes that were not HISA compliant. The horse was scratched by the stewards.

7<sup>th</sup> RACE An objection was lodged by the rider of fifth place #13 "Iguazu (IRE)" (Gerardo Corrales) alleging interference by the rider of third place #2 "Daisy Jones" (Gavin Ashton) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #13 came in and made contact with #2, who then angled out and bumped #13 several times, causing #13 to steady and lose momentum. For the interference #2 was disqualified from third and placed fifth, behind #13.

8<sup>th</sup> RACE CLEAR

9<sup>th</sup> RACE #12 "Blueberry" arrived in the paddock with hind horseshoes that were not HISA compliant. The horse was scratched by the stewards when the paddock blacksmith was unable to pull the hind shoes., as requested by the trainer.
