1st RACE Voided claim - submitted for scratched horse

2nd RACE An objection was lodged by the rider of sixth place #6 "San Marco City" (Eder Luis Martinez) alleging interference by the rider of second place #3 "Warrior's Place" (Axel Concepcion) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.

After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence of interference to warrant a disqualification and the race was posted official.
