2nd RACE Voided claim - used stable name only and no horse listed

Both #3 "Chipsire" (Albin Jimenez) and #7

"Momma Rio" (Javier Padron-Barcenas) were late scratches from the post parade on the advice of the KHRC veterinarian.

3rd RACE CLEAR

4th RACE #7 "Pennyrile" (Joseph Talamo) was pulled up near the 3/8 pole for the second DNF in 2 starts and was placed on the Stewards' List.


5th RACE An objection was lodged by the rider of sixth place #11 "Leblon" (Alex Achard) alleging interference by the rider of fourth place #3 "Happy Camper" (Joshua Morales) near the 1/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.

6th RACE CLEAR

7th RACE #8 "Lady Fatima" (Albin Jimenez) popped the front door of the gate open, but was held in place by the assistant starter and the rider stayed aboard. The door was closed and the start was without incident.
