2<sup>nd</sup> RACE Voided 2 claims - submitted by the same stable for a single horse.

#4 "Play the Blues" (Orlando Mojica) was injured in the paddock and was a late scratch on the advice of the KHRC veterinarian.

#9 "Totalitarian" (Andres Patricio Ulloa) was injured in the starting gate and was a late scratch on the advice of the KHRC veterinarian.

A Stewards Inquiry was posted involving the stretch run and, in addition, an objection was lodged by the trainer (Wesley Ward) of second place #1 "Sherwood Avenue" (Walter Rodriguez) alleging interference by the rider of the unofficial winner, #6 "Lucky's Secret" (Gerardo Corrales) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #6 angled in and forced #1 to check and lose momentum. For the interference #6 was disqualified and placed second behind #1.

3<sup>rd</sup> RACE CLEAR

4<sup>th</sup> RACE #8 "Silver Sea" (German Terraza) was a late scratch from the post parade on the advice of the KHRC veterinarian.

5<sup>th</sup> RACE An objection as lodged by the rider of sixth place #11 "Saltwater Taffy" (Abel Cedillo) alleging interference by the rider of second place #1 "Pin Up Betty" (Axel Conception) near the 1/16 pole. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence of interference to warrant a disqualification and the race was posted official.

6<sup>th</sup> RACE Objections were lodged by both the rider of sixth place #1 "Danseur d'Oro" (Gerardo Corrales) and second place #5 "Judy's Ms. Officer" (Abel Cedillo) alleging interference by the rider of the unofficial winner #6 "You're Avoiding Me" (Colby Hernandez) near the 1/2 mile pole. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence to warrant a disqualification and the race was posted official.

9<sup>th</sup> RACE Voided claim - insufficient funds

The claim of #9 "Mikita" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
