The horses were returned to the paddock from the post parade during the delay. After the building was inspected and the return of patrons and staff was approved, the horse once again were sent out for a short post parade. Ultimately, the race was run without incident.

It was later reported that the alarm was due to a water flow alarm in the system that feeds the main canopy area. The cause of the problem was found to be a failed ball valve that resulted in the flow sensor being triggered.
